During law school, she was a student law clerk to the Honorable Robert Broomfield in the U.S. District in Phoenix. Upon graduation, Donna was the last law clerk to Justice William Holohan of the Arizona Supreme Court. After a brief stint in private practice, she left to start her career at the Maricopa County Public Defender's Office. Working in the trial division, she eventually rose to be supervisor of a trial group and then Chief Trial Deputy of an office of over 200 lawyers. In the process, she defended a number of capital cases, including one trial; she has been qualified to serve as first chair counsel on capital cases in Arizona. In

2002, she left that office to start work as an Assistant Federal Public Defender in the Phoenix Federal Defender's Office, where she did trials and appeals. From 2006 to 2008, Donna taught trial advocacy courses at the Sandra Day O'Connor College of Law as Adjunct Faculty. She has also taught at numerous seminars on such topics as ethics and professionalism, trial advocacy, criminal evidence and procedure, and mental health in criminal defense. She is a founding faculty member of the annual trial college for state public defenders in Arizona. She has also published widely in these areas and others related to the practice. In 2008, the American Bar Association published a book she authored on Vouching. In 2008, she was selected as the Federal Defender for the Middle District of Florida.

# Nicole Hardin, Assistant Public Defender, Fifth Judicial Circuit, Marion County, FL

Nicole Valdes Hardin is an Assistant Public Defender for the Fifth Judicial Circuit in Marion County, Florida and has worked for the Public Defender's Office since 2006. She currently handles felony cases and is qualified as co-counsel for death penalty cases. Ms. Hardin has been a part of the homicide defense team on seven murder cases in addition to her regular caseload. It was while working on a case for a defendant charged with first degree murder that Nicole first encountered stacks of cell phone "tracking" records, allegedly tying her client to the crime scene area. The State Attorney's Office was seeking the death penalty with their main evidence an eye witness with credibility problems and cell phone records. She struggled to understand the technology behind the tracking capabilities of cell phone towers, determined to identify their weaknesses. Additionally, she sought to suppress the evidence using federal and state law. Eventually, through research and working with experts, she was able to understand enough about the technology of cell phone towers to attack the process of tracking during cross examination. The tireless work of the defense team resulted in a hung jury. The State sought a new trial, but dropped the death penalty. On the second trial, lead counsel Tricia Jenkins and Nicole were able to secure an outright acquittal for the defendant. Wanting to share her new found information, Ms. Hardin contributed to articles attacking the science of cell phone tracking in criminal cases in two publications. She additionally has met with and helped to pass on expertise and materials to other defense attorneys facing the same circumstances. Nicole has also worked to develop felony sentencing training seminars for incoming felony attorneys at her office. The success of those presentations earned Ms. Hardin an invitation to co-present at a statewide defense conference on effective mitigation in sentencing. She attended the City University of New York at Queens College School of Law and is a proud alumnus of their Defender's Clinic. She is a member of the Florida Association of Criminal Defense Attorneys.

# Darren Johnson, Federal Public Defender, Northern District of Florida, Gainesville, FL

Darren Johnson is an Assistant Federal Public Defender for the Northern District of Florida. Prior to relocating to Florida, he was with the Office of the Federal Public Defender for the Eastern District of Virginia. Rob Mason is the Director of the Juvenile Division for the Public Defender's Office in the Fourth Judicial Circuit and has been an Assistant Public Defender since 1990. He is Chair of the Florida Public Defender Juvenile Justice Committee and a past Chair of the Florida Juvenile Rules Committee and the Legal Needs of Children Committee. As Chair of the Juvenile Court Rules Committee he helped implement a court rule mandating that juveniles have a right to confer with counsel before making a decision whether to waive counsel. He has also successfully argued twice before the Florida Supreme Court for the adoption of a court rule prohibiting indiscriminate shackling of juveniles for court appearances and a court rule mandating a court pronouncement to children as to possible immigration consequences before the court can accept a plea. Mr. Mason has authored the chapter "Disposition in Delinquency Cases" in Florida Juvenile Law and Practice. He has testified on juvenile issues before committees of the Florida Senate and Florida House and has lectured nationally on various juvenile issues. Mr. Mason was the trial attorney in the case of J.R. v. State, a case of first impression in Florida allowing a parent to remain in the courtroom during trial even when they are a defense witness and the rule of sequestration has been invoked. The MacArthur foundation honored him as a 2010 Models for Change "Champion for Change".

### Seth Miller, Esq., Executive Director, Florida Innocence Project

Seth Miller, Esq., litigates post-conviction DNA cases, supervises the IPF's internship program, and regularly lectures to students, lawyers, and community groups on issues related to wrongful convictions. He also teaches Post-conviction Remedies and Wrongful Convictions as an adjunct professor at the Florida State University College of Law. He currently serves on the Board of Directors of the Innocence Network, a consortium of more than 60 innocence projects from the United States and abroad. Before joining IPF in 2006, Mr. Miller served as a project attorney with the American Bar Association Death Penalty Moratorium Implementation Project in Washington, D.C., and as a staff attorney with the First District Court of Appeal in Tallahassee,
