#### **Exonerated**

Aaron Salter, Exoneree, Innocence Maintained (Nonprofit), Detroit, MI

Aaron Salter was accused of murder after being falsely identified in August of 2003. Pair that with an ineffective counsel and a lack of original trial investigation, and Aaron was convicted in 2003 after a jury trial. Over the next 15 years, Aaron fought for his freedom, despite the appellate process failing him. In 2018, with the formation of the Wayne County Conviction Integrity Unit, and due to an extensive investigation on the case by the team put together by his new attorney, Aaron was released from prison on August 15, 2018.

Aaron is teaching people on how to be better and not bitter, and started a nonprofit organization, Innocence Maintained (<a href="https://www.innocencemaintained.org/">https://www.innocencemaintained.org/</a>), to assist in the exoneration process of others and to support exonerated people with their reintroduction to society.

# The Challenges and Ethics of Investigating Intimate Partner Violence (Part I)

We will explore the many defenses in domestic or intimate violence that we see in our cases from an accidental, false accusations, lack of intent, self-defense and defense of others, diminished capacity, intoxication, alibi, necessity, and a parent's right to discipline a child – to name a few. Who witnessed the incident? Was it intentional? Are the witnesses credible? Injuries? Who called 911? Social media evidence? Were the parties consuming alcohol and/or drugs? Severe mental health issues during the incident? Who started the conflict and why? Was the issue about the discipline of the child, and not assault? What if the client shows up in the middle of the interview? Is the investigator a witness to the violation of an order of protection? The answers to these questions and more could provide you with the foundation for the best defense for client.

## Not in Our Name: Abolishing the Death Penalty in New Hampshire

Elizabeth & Renny Cushing, NH Public Defender, NH State Legislator, NH

On May 30, 2019, New Hampshire became the 21<sup>st</sup> state to ban capital punishment when the legislature overrode a gubernatorial veto and voted to repeal the death penalty. Representative Renny Cushing –a nationally recognized advocate for victims of crime victims and for human rights – was the prime sponsor of the repeal legislation and a leader of the decades long "anti-gallows" struggle in the Granite State. Cushing's father and brother-in-law were both murdered, and those painful experiences provide a frame for his work as a death penalty opponent. Elizabeth Cushing grew up in the echoes of her grandfather's murder, as well as the murder of her uncle in her early adulthood. She used these life experiences as motivation in her work as a criminal defense investigator in the state of New Hampshire, as well as her life-long work towards death penalty abolition. They will share some personal insights and lessons learned from the success of the New Hampshire repeal effort and prospects for similar victories in other states.

#### The Forensic Engineering Analysis of Surveillance Video: Real-World Examples

This presentation will systematically review the data required to complete a proper three-dimensional analysis; the sources of the data; the manner in which the data needs to be collected and processed; the required software; the expected accuracy level of the analysis; and how the results of the analysis can be presented to the trier of fact.

Attendees will learn how the video is "corrected" to remove the curvature from the lens; how the video is camera matched within an accurate, three-dimensional environment; how objects within the video are "tracked" within the environment; and how the combination of these processes combine to create an accurate, three-dimensional environment illustrating the movements defined in the video from which speeds, spatial relationships and sight distances can be evaluated.
