**PARKING:**

**SHUTTLE SERVICE:**

**Airport Shuttle:** "Airline Shuttle" provides round trip transportation from McCarren International Airport to/from the Golden Nugget for \$15.00 round trip. Call 702-798-3498 to make a reservation. There is also a Budget Rent a Car located on site at the Golden Nugget, open from 7:30 am to 5:00 pm. For more information go to. Taxi service is also available from the airport, located directly outside of baggage claim.

**TRANSPORTATION TO & FROM THE STRIP:**

There is a city shuttle called the "Deuce" bus that has a regular route up and down the Las Vegas Strip. The Deuce bus costs \$3 per person for a one way pass or \$7 for an all-day pass. There is also a new Bus Route called the "ACE EXPRESS" which takes you down to the convention center and also to the Strip. The bus stop to the Strip is located on Fremont St. and Casino Center Blvd. The bell desk can also help you set up a limousine with an outside limousine company of your choice. Taxi cabs are another option, and can be easily accessed through the Gold or Rush Tower Entrances. A cab can only take a maximum of 4 people. Please see one of the doormen for more info on taxi cabs.
