Jason Carroll's Story: The Coerced Confession of a Teenager that led to a 33-Year Fight for Innocence

At 19, Jason Carroll finally found a job he really liked, working with the National Guard as a mechanic. He even thought he would maybe make a career out of it. But Jason's plans came to a screeching halt when state police came into his workplace one day to speak with him about a murder that had gone unsolved for over a year. Over the course of the next few days, teen-aged Jason was subjected to hours of grueling interrogation. Even his mother, a local cop, engaged in pressuring Jason to admit involvement in the crime. The statements pulled from Jason during those days formed the basis for capital murder charges. The only problem? The statements Jason made just don't match the facts...This session will focus on the facts of the case and the fight to free Jason Carroll from incarceration based on his wrongful conviction.
